Meeting Minutes

The November meeting minutes were unanimously approved via email prior to the meeting. There was no meeting in December.

Committee reports

- 1. Treasurer Ray Newman
 - a. Ray provided a year-end financial summary. He reported there are excess funds due to projects that were not completed, i.e., a fall clean-up, dock door, and pavilion fireplace repair.
 - b. He will be submitting the taxes in January.
 - c. One resident is paying dues in installments and is now \$200 behind in 2024 payments.
 - d. Ray will send out a draft 2025 budget for review.
 - e. The discretionary budget was discussed. Also, whether the fireplace should remain gas or switch to electric. No decision was made.
- 2. Preservation Lane Ray Newman
 - a. Ray reported there were 2 maintenance repairs completed one with rocks and one without. The road looks good and rocks are not needed in 2025 so there will be a funds residue.

Correction - 2 regular maintenance repairs completed - both without gravel allowing for a 2024 budget residual. Gravel maintenance will be done in 2025.

- 3. ARB Stacy Domingo
 - a. Stacy summarized recent requests and approvals.
 - b. Her son cleaned the pavilion fireplace reporting all the front coverings were disposed of due to breakage.
 - A letter outlining HOA Board actions and fines issued to the Trans was given to the McClellans.
 Stacy confirmed that there has been no response from the Trans to the certified mail letters for

the fines. Due to Bob McClellan's recent encounter and reporting to Animal Control, the Trans are being fined by the city and were told to remove the dogs. The McClellans will give the letter provided by the Board to Animal Control.
