FROM THE PRESIDENT

First let me thank those owners who made it a priority to maintain their homes to the highest standards. We still have lingering issues of homes in need of pressure washing, repairs and applications of pine straw and mulch. Also we ask you to review specifically Article V Use and Restrictions and Article X Maintenance and Repair of the Declaration of the Covenants and Restrictions for The Refuge at Whitehall to ensure you are in compliance.

The fall is here and leaves are falling and we ask that you manage theses leaves so as to not create an eyesore and prevent migration into your neighbor's yard or streets.

In the New Year we are planning on providing you with a simpler user friendly version of standards for use in maintaining your property.

Have a happy holiday season and be on the lookout for potential hazards and especially those surrounding electrical and cooking fires.

FROM THE PLAC CHAIRMAN:

The Preservation Lane Advisory Committee held a meeting on October 22 with several residences that live on the lane in attendance. The points of discussion included: History of Preservation Lane, effectiveness of most recent maintenance and advising the HOA board as to a maintenance plan, evaluation of the problem areas and reporting schedule. The advisory committee plans to evaluate Preservation Lane each quarter and present to the HOA board its' recommendations for maintenance, if any are required, along with potential problem areas which may need to be reevaluated/addressed at a later date.

The PLAC members have received much positive feedback from the most recent maintenance.

The current status of Preservation Lane roadway seems to be holding up well, except a few areas, which will be re-evaluated in January. It is estimated that it will take about 1 to 1.5 loads of crushed concrete at the most. The committee is also researching solution to fill in the jasmine on the fence at the beginning of the lane.

If you live on the lane, consider joining this committee, your input is valuable to the future enhancements.

The primary function of the Common Property Advisory Committee (CPAC) is to assist the board of directors in fulfilling their oversight responsibilities in assessing the viability, acceptability, and adherence to standards and owners satisfaction with common properties. The planning for 2014 has begun and therefore if you are interested in assisting the committee, please do not hesitate to contact the CPAC Chairman; Thanks.

Major common properties: Front Entrance, Pond, Pavilion and Dock.

Previous CPAC efforts resulted in the following improvements:

- Pavilion Motion Sensor and Light Installation
- Procurement of New Cushions for the Pavilion
- Placement of Two New Picnic Table in the Pavilion
- Secured City Trash Can Service for the Pavilion
- Safety Repairs to the Floating Dock
- Purchased New Light Kit for the Pond Fountain
- Sidewalk Extension with Wheel Chair Accessibility
- Crosswalk
- Crosswalk Warning Signs

Pending CPAC Recommendations:

- Installation of a Safety Mirror at the Front Entrance at the Curve

- Gas be Reinstalled at the Pavilion, with Controls and or Lock on the Shut-Off Valve.
- Purchasing Replacement Bulbs for the Landscaping Lights at Entrance and Pavilion.
- Replacing the Gated Entrance to the Dock and Access Mechanism

Potential CPAC Interest Areas:

- Purchasing Lot 24 for the Refuge's Use
- Accessing the Adequacy and Level of Satisfaction with Front Entrance Appearance
- Structural Modification and Equipping of the Pavilion For Enhance Usage
- Protocols for Scheduling and Usage of the Pavilion by Owners
- Accessing the Adequacy and Level of Satisfaction with Playground
- Establishment of a Refuge Kayak Program to Enhance Dock Usage

The Refuge's 63-home neighborhood on 1/4 to 1/2 acre lots is a world apart from the hustle and bustle of everyday life. The community has a stocked pond, spacious pavilion and a community boardwalk with a dock extending into unspoiled Coosaw Creek. There's a 35-foot height restriction, 20-foot setback from the street, perimeter sidewalks, and strategically placed gas lanterns. At least 30 percent of the plantings must be indigenous South Carolina foliage such as palmettos. The Refuge uniquely combines a feeling of a close-knit community with the quiet and serenity of nature in a setting steeped with history.
